GSA Contractw/Limited Availability: Traveler/AO must first complete the [Restricted Airfare Checklist](#) before determining if this is a good option. Further discounted GSA city pair fare for Federal government employees on official business. Fare is fully refundable and changeable.

Flights under the Other Gov't Airfare, Other Airfare, or AltGSA should only be authorized when flights under the GSA contract Airfare or GSA Contractw/Limited Availability are not available or do not meet mission requirements.

The traveler must make annotation on the authorization so that the AO can make the determination on whether or not to authorize flights under Other Gov't Airfare, Other Airfare, or AltGSA.

Other Gov't Airfare: Competitive fares offered by airlines which may include combined city pair fares in non-city pair markets; any fare chosen may require justification and approval by your Authorizing Official.

Other Airfare: Fares offered to the general public; refundable but may have advance purchase requirements. Selecting this fare requires justification and approval by your Authorizing Official.

AltGSA: Additional airports offering government contracted fares to increase your options.

Note: Camp Pendleton and Miramar travelers must set the Departing Airport to "San - San Diego International"
