Subj: LETTER OF INSTRUCTION FOR THE ENLISTED ASSIGNMENT BRANCH COMMAND
VISIT DURING THE PERIOD OF 7 THROUGH 30 MARCH 2017

1. Situation. Marine Corps Forces Special Operations Command (MARSOC) Screening Team (HMST) will visit Marine Corps Base Camp Pendleton, Marine Corps Air Station (MCAS) Miramar, Marine Corps Air-Ground Combat Center (MCAGCC) Twentynine Palms (29 Palms), and MCAS Yuma during the subject period.

2. Mission. The HMST will visit designated West Coast commands to provide orientation briefs and conduct individual interviews to identify qualified Marines to attend Assessment and Selection (A and S) and if selected, attend the Individual Training Course (ITC). Graduates of ITC may fill Critical Skill Operator (CSO) billets in support of the MARSOC mission.

3. Execution

a. Commander's Intent and Concept of Operations

(1) Commander's Intent. Marines that have been identified as potentially qualified for assignment to MARSOC and are to be screened by the HMST per Reference (a). Unless officially excused by Manpower Management Enlisted Assignments (MMEA) branch, all Marines that have been designated by their respective Commanding Officers (COs) via their unit's Sergeants Major or Career Planners are required to attend the orientation brief at their respective bases. Marines must attend one of the briefs/screenings as listed in enclosure (2). If a Marine listed on the HMST roster has been previously screened by MARSOC they are not required to attend the HMST brief.

(2) Concept of Operations

(a) Each Marine will report to the HMST in the seasonal service uniform. Only volunteers on the HMST roster will be required to have in their possession: MARSOC COs Screening Checklist, Financial Worksheet, Clearance Screening Questionnaire, and MARSOC Health Questionnaire.

(b) All Marines are expected to report for screening. COs via the unit's Sergeant Major or Career Planner must provide the HMST Officer In Charge (OIC) with a roster of Marines not available for HMST brief/screening with justification. Commands should ensure Marines unable to attend a

(c) Volunteers who are not listed in enclosure (2), who meet the prerequisites and will attend the brief/screening are required to complete the action listed in reference (a).

(d) Marines' spouses, Marines interested in future assignment to MARSOC, and Commanding Officers and Sergeants Major are encouraged to attend a HMST orientation brief.

b. Tasks

(1) Assistant Chief of Staff (AC/S) G-1, I Marine Expeditionary Force (MEF)

(a) Coordinate the overall visit to Marine Corps Base Camp Pendleton for MARSOC.

(b) Make liaison with the Career Planner, Marine Corps Installations West (MCI-W) to ensure:

1. At designated locations, adequate venues to accommodate the MARSOC visit schedule.

2. Each site has audio-visual support, projection capability, and computer (internet) access available for all briefs, interviews, and counseling sessions.

(2) Commanding General, MCI-W. Request help to items listed in paragraph 3b(1)(b) at designated locations listed in the enclosure.

(3) Commanding Generals, Major Subordinate Commands and Major Subordinate Elements. Ensure widest dissemination of information pertaining to the MARSOC visit. Ensure all available Marines and their leadership are afforded the opportunity to attend the briefs.

4. Administration and Logistics. All personnel attending briefs, speaking with the HMST will be in the Seasonal Service Uniform. All Career Planners will be in the Seasonal Service Dress Uniform.
