Subj: I MARINE EXPEDITIONARY FORCE (MEF) ORDER ON SMALL ARMS  
TRAINING UTILIZING LIVE AND BLANK AMMUNITION

Ref: (a) Article 92, Uniform Code of Military Justice (UCMJ)

1. Situation. This Order applies to all U.S. military and civilian personnel assigned, attached, serving with, or performing I MEF duties in the Continental United States (CONUS) or outside the Continental United States (OCONUS).

2. Cancellation. I MEFO 3574.1.

3. Mission. To establish mandatory requirements and standards for I MEF units conducting small arms firing with live ammunition followed by training with blank ammunition. The M4 carbine, the M16A2 rifle, the M27 Infantry Automatic Rifle (IAR), the M249 Squad Automatic Weapon (SAW), the M240G machinegun and the M2HB.50 machinegun are covered by this Order. 9MM simulated munitions (DODICs AA12 and AA21) used for training with the paintball conversion kit for the M4 carbine and the M16A2 rifle, are not within the scope of this Order.

4. Execution

a. Commander's Intent and Concept of Operations

(1) Commander's Intent. To establish I MEF procedures that ensure the safe transition from live ammunition to blank ammunition during small arms training. The procedures established by this Order are mandatory. I MEF personnel who violate this Order may be punished under the UCMJ.

(2) Concept of Operations. It is prohibited to conduct small arms training with live ammunition followed by training with blank ammunition on the same calendar day. Small arms training with live ammunition may be followed by training with blank ammunition on subsequent calendar days provided that the procedures in paragraph 4(c) are followed.

b. Subordinate Element Missions. Adherence to this Order will prevent accidents caused by the negligent use of live ammunition during training requiring blank ammunition.

c. Coordinating Instructions. The following inspection procedures are required whenever small arms training with live ammunition is followed by training with blank ammunition:

(1) The Range Safety Officer (RSO) will establish an inspection site. The purpose of the inspection site is to collect and account for all live

ammunition before issuing blank ammunition for the next training event. Adequate space, illumination and time are needed to properly operate the inspection site.

(2) The inspection site will contain three stations which will operate sequentially under the direct supervision of the RSO:

(a) DOWNLOAD STATION. The RSO supervises the removal of all unexpended live rounds from magazines, uniforms and equipment.

(b) INSPECTION STATION. The RSO supervises pat-down inspections and magazine checks.

(c) ISSUE STATION. The RSO supervises the issue of the correct type of ammunition for the next training event.

(3) The RSO will supervise the download station.

(a) The RSO will ensure that all participants receive proper instructions regarding range procedures and the requirements of this Order.

(b) The RSO will ensure that all participants use the buddy system to download unexpended ammunition from magazines, pouches, uniforms and equipment.

(c) The RSO will use a roster provided by the training unit Officer in Charge (OIC) to ensure that all participants are accounted for at this station.

(d) The RSO will ensure live rounds are physically segregated and stored in properly marked containers.

(4) The RSO will supervise the inspection station.

(a) The RSO will ensure that all inspectors receive proper instructions regarding range procedures and the requirements of this Order.

(b) The RSO will ensure that a thorough pat-down inspection is conducted and that all individual clothing and pockets are inspected.

(c) The RSO will ensure a detailed magazine check is conducted for all weapons.

(d) All individual equipment will be displayed and inspected by the RSO or his/her designated safety assistants.

(e) The RSO will use a roster provided by the training unit OIC to ensure that all participants are accounted for at this station.

(5) The RSO will supervise the ammunition issue station.

(a) The RSO will ensure the correct ammunition is issued for the next training event.

(b) The training participants will ensure that their magazines are loaded with the correct ammunition.

(c) The RSO will ensure a test fire is conducted if feasible.

(d) The RSO will use a roster provided by the training unit OIC to ensure that all participants are accounted for at this station.


(6) Safety is a paramount concern. All officers, staff noncommissioned officers (SNCOs) and noncommissioned officers (NCOs) have a duty to supervise the safe conduct of training. The transition from live ammunition to blank firing is a situation where failure to closely supervise at all levels could lead to the serious injury or death of a Marine. Unit Commanders will ensure that OICs and RSOs are in compliance with this Order and governing regulations. This Order is in effect in order to prevent training accidents from occurring.

(7) This Order is punitive. Persons subject to the UCMJ who violate this Order may be punished under Article 92, UCMJ.

5. Administration and Logistics. Distribution will be made by electronic copy to Major Subordinate Command (MSC) G-3 and I MEF staff principals.

6. Command and Signal

- a. Command. This Order is applicable to all I MEF Subordinate Commands.
- b. Signal. This Order is effective the date signed.
