Subj: DESIGNATION OF THE LOCAL COMMUTING AREA

1. Situation. To designate the local commuting area for both active duty and reserve Service Members and civilian employees aboard Marine Corps Base, Camp Pendleton (MCB Campen). All personnel are referred to as travelers within this Order.

2. Cancellation. BO 7220.13C.

3. Mission. On occasion, it is necessary for travelers to commute to adjacent cities and installations on official business. Paragraph 0206 of reference (a) permits the commander directing and authorizing travel to specify a local commuting area for reimbursement purposes.

4. Execution

a. Commander's Intent and Concept of Operations

(1) Commander's Intent. To establish the local commuting boundaries for reimbursement purposes.

(2) Concept of Operations. Per reference (b), an arbitrary distance radius from the point of departure must not define establishment of the local commuting area. The "local area" is defined as the area within the Permanent Duty Station (PDS) limits and the metropolitan area around the PDS served by the local public transit systems; the local commuting area, and the separate cities, towns, or installations among which the public commutes on a daily basis.

b. Coordinating Instructions

(1) For Service Members and civilian travelers assigned to commands and tenant organizations aboard MCB CamPen, the enclosures depict the boundaries of the local commuting area.

(2) Travelers commuting from their home or permanent station to a designated area within the local commuting area on official business and returning the same day may be authorized travel via privately owned conveyance as advantageous to the government and may be reimbursed under the provisions of paragraph 020603 of reference (a). This Order applies where a traveler commutes within the designated local commuting area.


(3) Travelers may travel from their residence or PDS to the area of official business. However, paragraph 020603.(B).1.c.(1).(a) of reference (a) states that reimbursement will be based on mileage that exceeds the traveler's commuting distance. Claims for reimbursement for local area travel will be performed in the Defense Travel System using the "local voucher" option and completing the required information therein.

6. Command and Signal

a. Command. This Order is applicable to all commands, organizations, units, and activities located aboard MCB CamPen.






Orange, Riverside and Northern San Diego Counties
